**ASSUMPTION OF RISK AGREEMENT, WAIVER, RELEASE AND COVENANT NOT TO SUE.  
(READ CAREFULLY BEFORE SIGNING)**

The undersigned assumes all responsibility for any and all risk of damage or injury that may occur to the undersigned and his/her property as a participant at the shooting range and/or firing range activities utilizing the discharge of fire of firearms including, but not limited to pistols, long guns, shot guns and other weapons or competition guns of every kind and character and referred to in this assumption of risk agreement, waiver, release, and covenant not to sue, while participating in any such exercises or being present as a spectator while at the firing range premises. In consideration of participating, being present as a spectator, or present on the premises at any time, the under-signed hereby releases and discharges Nathan R. Hendrix, Heidi H. Hendrix, and their heirs, executors, administrators, assigns, agents, range officers, and range safety personnel from all claims, demands, rights of cause of action, present or future, whether known, anticipated or unanticipated and resulting from or arising out of, or incident to, the undersigned's use (or intended use), of the firing range or facilities and equipment at such firing range or as result of, or incident to, engaging in firing range activities, witnessing firing range activities, or being present otherwise, either directly or indirectly, being involved in firing range activities of any nature on property owned by Nathan R. Hendrix and /or Heidi H. Hendrix.

The undersigned does hereby acknowledge and appreciate the danger and risk associated with being present as a spectator, participant, or otherwise at the firing range at which firearms will be or are being discharged and acknowledges that there is potential for property damage, personal injury and/or death when present and voluntarily appearing at a place where or near where firearms are being discharged and I fully understand and appreciate this risk. I do hereby execute this document with such understanding and knowledge of this dangerous activity, which I am attending, and I am freely and voluntarily present and further, execute this agreement as my own free act and deed. In other words, I am releasing, waiving my rights, acknowledging the assumption of risk, and agreeing not to sue the Cross Roads Sport Shooting Association, its owner(s), its affiliates or other organizations in which this club may be affiliated or associated with, or its members and/or directors. *This document / instrument shall remain in full force and effective indefinitely.*
